

Applicant seeks approval for its Easi Horseshoe Gallup Unit consisting of 4,762.57 acres, more or less, of federal and fee lands sit uated in all or parts of Sections 3-5, 7-9, and 17-19 of Township 30 North, Range 15 West N.M.P.M., San Juan County, New Mexico. The Unitized Interval, includes all formations from the base of the Point Lookout Sandstone to the base of the Greenhorn Limestone Member of the Mancos Shale.
