**APPLICATION**

EOG Resources, Inc., ("EOG") (OGRID No. 7377), through its undersigned attorneys, hereby makes application pursuant to NMAC 19.15.20.12.D to (1) create a new Wolfcamp pool; and (2) increase the depth bracket allowable for oil wells within the WC-025 G-09 S263327G; Upper Wolfcamp Pool (98097). In support of this application EOG states:

1. The WC-025 G-09 S263327G; Upper Wolfcamp Pool is a wildcat pool established by EOG Resources Inc. as the result of the discovery of hydrocarbons in the Ophelia 27 No. 703H Well (API No. 30-025-42045) located in the SW/4 NE/4 (Unit G) of Section 27, Township 26 South, Range 33 East, NMPM, Lea County, New Mexico. Pursuant to Division Rule 19.15.20.12.A, this pool was assigned a depth bracket allowable of 410 barrels of oil per day for each 40-acre spacing unit.

2. The Division district office has informed the Applicant that the WC-025 G-09 S263327G; Upper Wolfcamp Pool currently comprises the following acreage in Lea County, New Mexico:

**Township 26 South, Range 33 East, N.M.P.M.**

Section 21: All  
Section 22: W/2, SE/4  
Section 25: W/2

Section 26: N/2  
Section 27: NE/4  
Section 28: E/2  
Section 33: E/2  
Section 36: W/2

3. EOG has recently completed three horizontal wells in Section 16, Township 26 South, Range 33 East: the Braswell 16 State No. 707H 30-025-43402), the Braswell 16 State No. 708H (API 30-025-43403), and the Braswell 16 State No. 709H (30-025-43404). Each well is producing from the WC-025 G-09 S263327G; Upper Wolfcamp Pool. The completed interval for each well is within the Wolfcamp formation at a depth ranging from 12,198 TVD to 12,258 TVD. These wells demonstrated that they are capable of production at rates in excess of the depth bracket allowable currently assigned to wells in this pool.

4. EOG's analysis of the WC-025 G-09 S263327G; Upper Wolfcamp Pool indicates that increasing the depth bracket allowable from 410 to 1,400 barrels of oil per day for each 40-acre spacing unit will not damage the reservoir or cause waste of the remaining reserves.

5. In order to allow EOG and other operators in the WC-025 G-09 S263327G; Upper Wolfcamp Pool to efficiently and effectively produce the oil reserves, EOG requests that the Division increase the depth bracket allowable from 410 to 1,400 barrels of oil per day for each 40-acre spacing unit.

6. After consultation with the Division district office, EOG requests that creation of the **Sanders Tank**; Upper Wolfcamp Pool to correspond with the boundaries of the WC-025 G-09 S263327G; Upper Wolfcamp Pool.

7. All other rules for this pool shall remain in conformance with statewide rules for oil wells.


8. Notice of this application will be provided to the Division designated operators in the WC-025 G-09 S263327G; Upper Wolfcamp Pool as well as the Division designated operators and working interest owners within the Wolfcamp formation within one mile of the pool's outer boundary.

9. Approval of this application is in the best interests of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, EOG respectfully requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 30, 2017, and that after notice and hearing, the Division enter an order approving this application.
