Good afternoon Sarah & Jeff,

WPX is currently preparing to go to hearing with the NMOCD to request an extension of the closure requirement of the Section 30 Recycling Containment (NMOCD permit #3RF-3) that is located on BLM land in Section 30, T31N; R5W in Rio Arriba County. Approval of this extension will allow WPX to continue utilizing this existing recycling containment for operations in the Rosa area, thus avoiding additional surface disturbance that would be necessary in order for WPX to utilize recycled water for the upcoming drilling and completion activities scheduled for 2017 if this extension is not approved.

WPX is requesting a response to this email from BLM, as the surface owner, in support of this extension.
