Mewbourne Oil Company applies for an order (i) approving a non standard spacing and proration unit in the Wolfcamp formation comprised of the E½ of Section 2 and the E½ of Section 11 Township 25 South, Range 28 East NMPM Eddy County, New Mexico and (ii) pooling all mineral interests in the Wolfcamp formation underlying the non standard unit and in support thereof states

- 1 Applicant is an interest owner in the E½ of Section 2 and the E½ of Section 11, and has the right to drill a well thereon

- F Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well
