STATEMENT OF THE CASE

The New Mexico Oil Conservation Commission ("the Commission") commenced this proceeding on its own motion, proposing amendments to Rules 19.15.7.16 NMAC and 19.15.16.19 NMAC (1) to require filing of fracture treatment disclosures through the FracFocus Chemical Disclosure Registry, and (2) to extend the time for filing completion reports concerning horizontal wells from 20 days to 45 days after completion. The purpose of the proposed rule amendments is (a) to coordinate fracture treatment disclosure rules with those of numerous other states that utilize FracFocus, and (b) to allow filing of completion reports for horizontal wells to be deferred until a time when required information is more likely to be available, thereby limiting the necessity for filing amended reports.

OCD has proposed an alternative to the rule attached to the Commission's Order which (1) eliminates the requirement in the Commission's proposal for duplicate filing with OCD, (2) extends the requirement for fracture treatment disclosure filing to fracture treatments in connection with re-completions or workovers, as well as original completions, and (3) extends the deferral of completion reporting to 45 days after completion to non-horizontal, as well as horizontal wells. The purpose of the proposed alternative is to eliminate duplication of fracture treatment disclosure filings, and to reduce potential for confusion by having a single requirement for disclosure filing and a uniform time for completion reporting.
