The proposed non-standard spacing and proration unit is comprised of the E/2 of Section 6, Township 10 South, Range 28 East, NMPM, Chaves County, New Mexico.

This matter is scheduled for hearing at 8:15 a.m. on Thursday, June 8, 2017 in Porter Hall at the Division's offices located at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. 34T Holding LLC ("34T") is not required to attend this hearing, but as an owner of an interest that may be affected by Back Nine's application, it may appear at the hearing and present testimony. If 34T does not appear at that time and become a party of record, it will be precluded from contesting the matter at a later date.

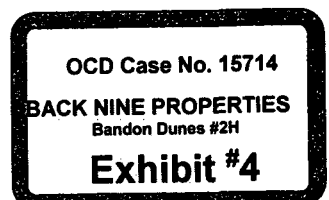

The Pre-Hearing Statement must also be provided to me.
