### STATEMENT OF THE CASE

Applicant seeks an order approving a non-standard oil spacing and proration unit comprised of the W/2 of Sections 12 and 13, Township 25 South, Range 28 East NMPM, Eddy County, New Mexico, pooling all mineral interests in the Wolfcamp formation, Purple Sage Wolfcamp Gas Pool (98220), underlying the non-standard unit. The unit will be dedicated to Applicant's Riverbend 12-13 Federal Com Well No. 29H. Note: at the direction of the BLM, the surface location of the well has been changed from 330 feet from the south line and 2200 feet from the west line of Section 1, Township 25 South, Range 28 East, NMPM to a new location 1042 feet from the south line and 1500 feet from the west line of Section 1. The bottom hole location remains 330 feet from the South line and 2200 feet from the west line of Section 13, Township 25 South, Range 28 East, NMPM.
