**STATEMENT OF THE CASE**

**APPLICANT**

Applicant seeks an order approving a 159.68-acre non-standard spacing and proration unit (project area) in the Bone Spring formation comprised of Lot 2, S/2NE/4, and SE/4NW/4 (the S/2N/2) of Section 18, Township 24 South, Range 29 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard spacing and proration unit (project area). The unit is to be dedicated to the Zach McCormick Fed Com. Well No. 122H, a horizontal well with a surface location in the SE/4NE/4 of adjoining Section 13 (Township 24 South, Range 28 East, NMPM), with a first take point in Lot 2, and a terminus in the SE/4NE/4, of Section 18. The producing interval will be orthodox. Also to be

considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
