STATEMENT OF THE CASE

Under these consolidated applications, OXY seeks orders creating two non-standard spacing and proration units and pooling all uncommitted interests in the Bone Spring formation underlying these units for the following acreage and proposed wells in Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico:

(1) a 320-acre non-standard spacing and proration unit comprised of the N/2 S/2 of Section 9 and the N/2 S/2 of Section 10, to be dedicated to its proposed **Turkey Track 9-10 State No. 23H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 8 to a standard bottom hole location in NE/4 SE/4 (Unit I) of Section 10; and

(2) a 320-acre non-standard spacing and proration unit comprised of the S/2 S/2 of Section 9 and the S/2 S/2 of Section 10, to be dedicated to its proposed **Turkey Track 9-10 State No. 24H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 8 to a standard bottom hole location in SE/4 SE/4 (Unit P) of Section 10.

The completed interval for each of these proposed wells will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.


