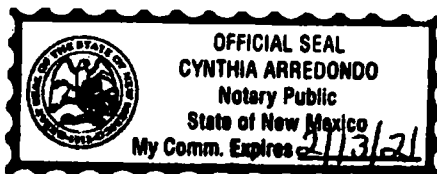

The estimated cost of drilling, testing, completing, and equipping the Well is \$6,289,398.00 as itemized on the enclosed Authority for Expenditure (“AFE”) dated March 29, 2016.

The proposed surface location of the Well is approximately 631’ FNL and 187’ FWL of Section 18, Township 24 South, Range 28 East, Eddy County, New Mexico. 

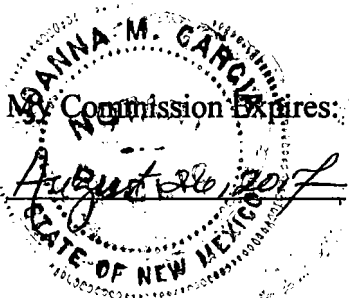


