Cimarex Energy Co. ("Cimarex"), OGRID Number. 215099, through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of NMSA 1978, Section 70-2-17, for an order: pooling all mineral interests in the Bone Spring formation underlying the 223.47 acre non-standard spacing and proration unit approved by the Division in Administrative Order NSP-2057, which is comprised of the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico. In support of this application, Cimarex states as follows:

1. Cimarex is an interest owner in the subject lands and has the right to drill a well thereon.

2. On December 19, 2016, the Division entered Administrative Order NSP-2057, approving the creation of a non-standard proration unit in the WC-015 G-04 S262625B, Bone Spring Pool (pool code 98018), which is comprised of 223.47 acres located in the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico.

3. Cimarex seeks to dedicate the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33 to the development of the proposed well (the "project area").

4. Cimarex proposes to drill the Klein 33 Federal Com. Well No. 10H as a horizontal well to a depth sufficient to test the Bone Spring formation. The proposed Klein 33 Federal Com. No. 10H well will be drilled with a surface location of 290' from the South Line and 780' feet from the East Line, Section 33, Township 26 South, Range 27 East, and a bottom hole location of 330' from the North Line and 590' from the East Line, Section 28, Township 26 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.

5. This project area is within the Pool WC-015 G-04 S262625B, Bone Springs (pool code 98018), and there are no special pool rules that apply. The producing interval that Cimarex seeks to drill will comply with the statewide 330 foot setback requirements.

6. Cimarex sought, but has been unable to obtain, a voluntary agreement from all interest owners in the Bone Spring formation underlying the proposed project area to participate in the drilling of the well or to otherwise commit their interests to the wells.

7. There is currently a dispute as to ownership of an unleased mineral interest. Cimarex sent well proposals to all persons claiming to own the interest, and will escrow any proceeds attributed to that interest until the ownership dispute is resolved. Cimarex will afford the ultimate owner the opportunity to either participate in the well with either a working interest or royalty interest.

8. Approval of the non-standard unit and the pooling of all interests in the Bone Spring formation underlying the proposed project area will prevent the drilling of unnecessary wells, prevent waste and protect correlative rights.

9. Notice of this application has been given in accordance with Division rules as shown on Exhibit A.

WHEREFORE, Cimarex Energy Co. requests this application be set for hearing before an Examiner of the Oil Conservation Division on May 11, 2017, and after notice and hearing as required by law, the Division enter its order:

A. Pooling all mineral interests in the Bone Spring formation underlying the 223.47 acre non-standard spacing and proration unit/project area, covering E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico;

B. Designating Cimarex as operator of this unit and the well to be drilled thereon;

C. Authorizing Cimarex to recover its costs of drilling, equipping and completing this well;

D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

E. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.

("Cimarex"), OGRID Number. 215099, through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of NMSA 1978, Section 70-2-17, for an order: pooling all mineral interests in the Bone Spring formation underlying the 223.47 acre non-standard spacing and proration unit approved by the Division in Administrative Order NSP-2057, which is comprised of the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico. In support of this application, Cimarex states as follows:

1. Cimarex is an interest owner in the subject lands and has the right to drill a well thereon.

2. On December 19, 2016, the Division entered Administrative Order NSP-2057, approving the creation of a non-standard proration unit in the WC-015 G-04 S262625B, Bone Spring Pool (pool code 98018), which is comprised of 223.47 acres located in the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33, Township 26 South, Range 27 East, NMPM, Eddy County, New Mexico.

3. Cimarex seeks to dedicate the E/2 E/2 of Section 28 and NE/4 NE/4 and Lot 1 of Irregular Section 33 to the development of the proposed well (the "project area").

4. Cimarex proposes to drill the Klein 33 Federal Com. Well No. 10H as a horizontal well to a depth sufficient to test the Bone Spring formation. The proposed Klein 33 Federal Com. No. 10H well will be drilled with a surface location of 290' from the South Line and 780' feet from the East Line, Section 33, Township 26 South, Range 27 East, and a bottom hole location of 330' from the North Line and 590' from the East Line, Section 28, Township 26 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.

5. This project area is within the Pool WC-015 G-04 S262625B, Bone Springs (pool code 98018), and there are no special pool rules that apply. The producing interval that Cimarex seeks to drill will comply with the statewide 330 foot setback requirements.

6. Cimarex sought, but has been unable to obtain, a voluntary agreement from all interest owners in the Bone Spring formation underlying the proposed project area to participate in the drilling of the well or to otherwise commit their interests to the wells.

7. There is currently a dispute as to ownership of an unleased mineral interest.
