APPLICANT

Case No. 15,758: Applicant seeks an order approving a 322.42-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the W/2W/2 of Section 1

and the W/2W/2 of Section 12, Township 22 South, Range 34 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the unit.




