



ConocoPhillips Company:

MRC Permian Company (“MRC”) proposes the drilling of Matador Production Company’s Guitar 10-24S-28E RB #121H well, located in Section 10, Township 24 South, Range 28 East, Eddy County, New Mexico, to the Bone Spring formation.

In connection with the above, please note the following:

The estimated cost of drilling, testing, completing, and equipping the Well is \$5,720,631 as found on the enclosed AFE dated April 24, 2017.

The proposed surface location of the Well is approximately 934’ FNL and 165’ FWL of Section 11, Township 24 South, Range 28 East, Eddy County, New Mexico. The proposed bottom hole location of the subject well is approximately 660’ FNL and 240’ FEL of Section 10, Township 24 South, Range 28 East, Eddy County, New Mexico.

The Well will have a targeted interval within the Bone Spring formation. We plan to drill the Well horizontally in the Bone Spring (~7,925’ TVD) to a Total Measured Depth of approximately 13,150’ resulting in a productive lateral of approximately 4,500’.

MRC reserves the right to modify the locations and drilling plans described above in order to address topography, cultural or environmental concerns, among other reasons. MRC will advise you of any such modifications.

ConocoPhillips Company will own an approximate 4.392084% working interest in the Well, subject to title verification.

MRC requests that you indicate your election to participate in the drilling and completion of the Well in the space provided below, sign and return one (1) copy of this letter to the undersigned.



Malaga; Bone Spring (Pool Code 42780) Structure Map (Top Bone Spring Subsea)






Malaga; Bone Spring (Pool Code 42780) Stratigraphic Cross Section A - A'




Malaga; Bone Spring (Pool Code 42780) Isopach Map (Bone Spring)




