





Gentlemen:

COG Operating LLC (COG), as Operator, hereby proposes to drill the Boone 16 State Com #3H well as a horizontal well to a depth sufficient to adequately test the Wolfcamp formation to a TVD of approximately 11,795' and a MD of 21,600' ("Operation"). The surface location for this well is proposed at an off-lease legal location in Unit C of Sec. 21 with a bottom hole location at a legal location in Unit C of Sec. 9, Township 21 South, Range 33 East, N.M.P.M., Lea County, New Mexico. The total cost of the Operation is estimated to be \$11,773,606 and a detailed description of the cost is set out in the enclosed Authority for Expenditure ("AFE").

COG is proposing to drill this well under the terms of the AAPL Form 610-1989 Operating Agreement (Horizontal Mod.) The Operating Agreement covers the E $\frac{1}{2}$ W $\frac{1}{2}$ of Section 9 and the E $\frac{1}{2}$ W $\frac{1}{2}$ of Section 16, T21S-R33E, Lea County, New Mexico ("Contract Area") which is enclosed for your review and approval. It contains the following general provisions:

- 100% / 300% / 300% Non-consenting penalty
- \$7,000/\$700 Drilling and Producing rate
- COG named as Operator

If you do not wish to participate in the Operation, COG would like to acquire a Term Assignment of your leasehold for the following general terms:

- 3 year primary term
- Delivering a 80% NRI, proportionately reduced
- \$750 per net acre bonus consideration

The Term Assignment offer is subject to the approval of COG's management and verification of title.

Ladies & Gentlemen:

This letter is to advise you that COG Operating LLC has filed the enclosed application with the New Mexico Oil Conservation Division. This application will be set for hearing before a Division Examiner at 8:15 a.m. on September 14, 2017. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices, located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 19.15.4.13.B to file a Pre-hearing Statement four business days in advance of a scheduled hearing. This statement must be filed at the Division's Santa Fe office at the above specified address and should include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.



Wolfcamp Pool Cross Section Map





