<u>Case 15726</u>: In the Matter of Proposed Amendments to Section 19 of 19.15.16 NMAC and Section 16 of 19.15.7 NMAC, Extending the Time for Reporting Completion from 20 to 45 Days, and Proposed Further Amendment of Section 19 of 19.15.16 NMAC to Require Operators to Report Certain Information Regarding Hydraulically Fractured Wells in the FracFocus Chemical Disclosure Registry.
