Detailed account of work done, nature and quantity of materials used and results obtained.

Pulled rods and tubing. Tested 7" OD casing to 1000# and casing tested o.k.. Ran Dowell spinner survey and survey indicated water zones 4181-87' & 4201-64'. Ran 129 jts. of 5" OD casing and set at 4238'. Cemented around shoe with 100 sacks. Opened DV tool at 3879' and circulated 70 sacks cement. Cemented thru DV tool with 225 sacks cement. Cement circulated. Drilled plug and tested casing shut-off. Tested o.k.. Perforated 5" OD casing 4181-83' and 4201-03' and squeezed with 100 sacks at max. pressure of 6000#. Perforated 5" OD casing 4200'-4208'. Treated new perms. w/500 gals. H-38 acid. After pumping and testing several days, well tested 54 bbls. oil, 360 bbls. sulphur water per day.
