

In the matter of the application of the Oil Conservation Division of the Energy and Minerals Department upon its own motion for an order for the creation of new pools in Chaves, Eddy, and Lea Counties, New Mexico, the reclassification of an existing gas pool in Lea County, New Mexico, the abolishment of an existing pool in Eddy County, New Mexico, and the extension of certain existing pools in Chaves, Eddy, Lea, and Roosevelt Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations, reclassifications, abolishments, and extensions should not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production and designated as the East Avalon-Delaware Pool. The discovery well is the Exxon Corporation Burton Flat B Federal Well No. 1 located in Unit E of Section 1, Township 21 South, Range 27 East, NMPM. Said pool would comprise:
