APPLICANT'S STATEMENT OF CASE

COG seeks an order (1) creating a 240-acre, more or less, spacing and proration unit comprised of the W/2 E/2 of Irregular Section 1 (Lot 2, SW/4 NE/4, and W/2 SE/4) and the W/2

NE/4 of Section 12, Township 26 South, Range 35 East, NMPM, Lea County, New Mexico; and (2) pooling all uncommitted interests in the Wolfcamp formation. The proposed spacing and proration unit will serve as the project area for its proposed **Ushanka Federal Com 23H Well**, which will be horizontally drilled from a surface location in the NW/4 NE/4 (Lot 2) of Irregular Section 1 to a standard bottom hole location in the SW/4 NE/4 (Unit G) of Section 12. The completed interval for this well will remain within the 330-foot offset as required by the Statewide rules for oil wells.


