APPLICANT'S STATEMENT OF CASE

EOG seeks an order from the Oil Conservation Division (1) creating a 240-acre spacing and proration unit comprised of the E/2 SE/4 of Section 11 and the E/2 E/2 of Section 14, Township 26 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage. EOG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Plucky 14 Fed Com No. 502H** (API No. 30-015-44144), which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 14 to a bottom hole location in NE/4 SE/4 (Unit I) of Section 11. This acreage is located within the Welch Bone Spring Pool (64010) and the completed interval for this well will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.




