STATEMENT OF THE CASE

Applicant seeks an order approving a non-standard oil spacing and proration unit in the Wolfcamp formation, Jal Wolfcamp Pool, comprised of the E/2E/2 of Section 19, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico, and pooling all mineral interests in the Wolfcamp formation underlying the non-standard unit.

Applicant proposes to drill its Prizehog BWZ State Com #2H well to a depth sufficient to test the Wolfcamp formation. Applicant seeks to dedicate the E/2E/2 of Section 19 to the well to form a non-standard 160-acre oil spacing and proration unit (project area) in the Wolfcamp
