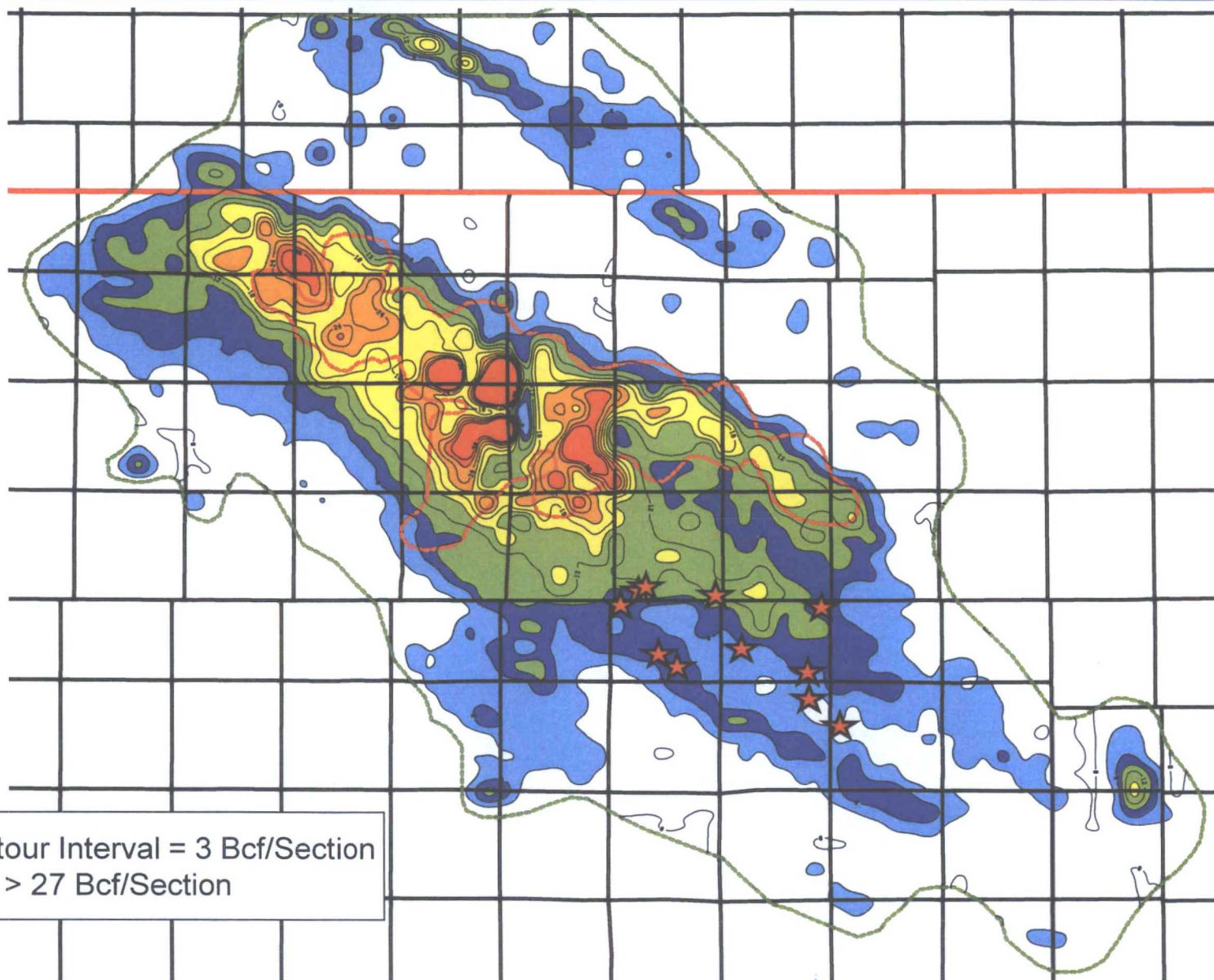


# MV Original Gas-in-Place





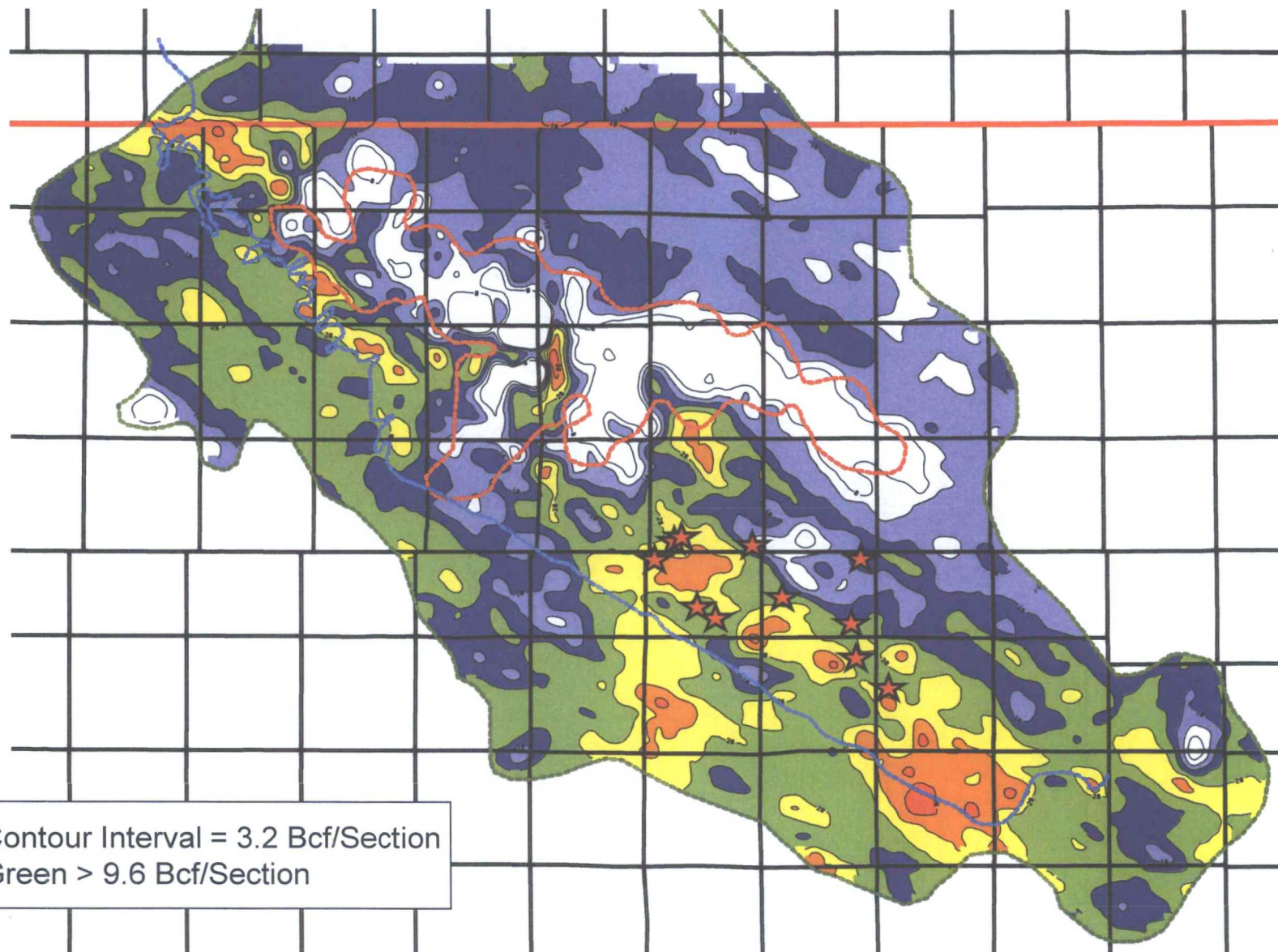
# MV Cumulative Gas Production

# MV Remaining Gas

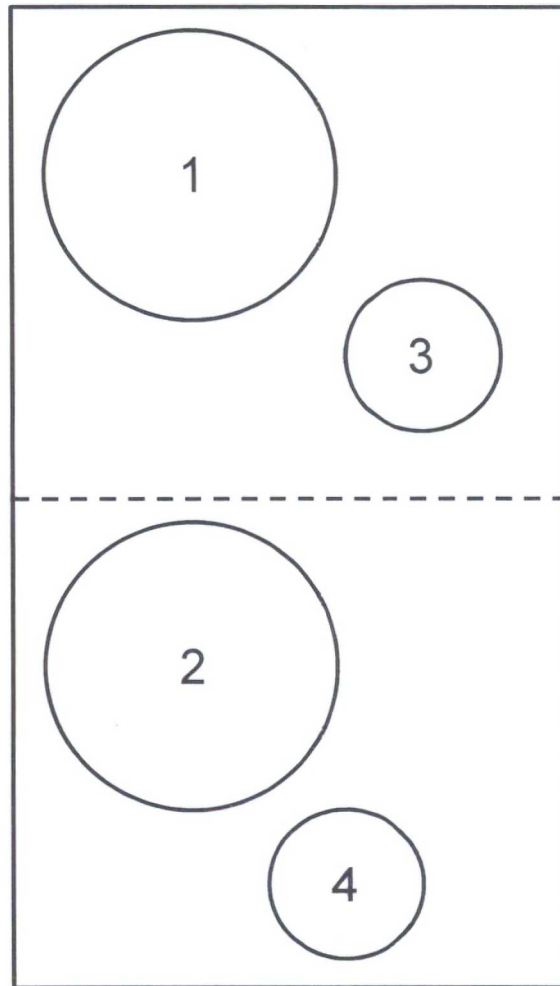

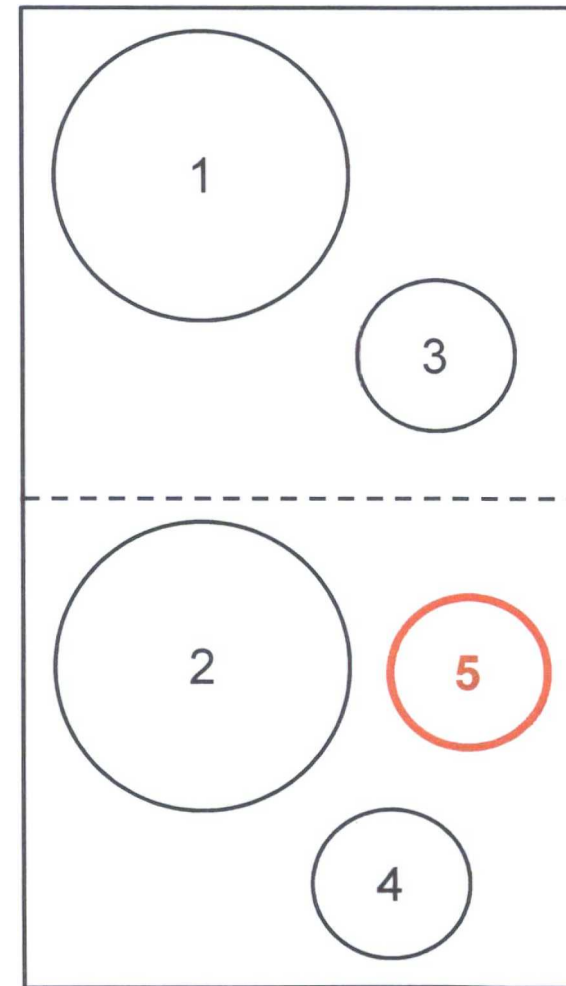
# Mesaverde Spacing Rule Exception

Current 80 Acre Rules



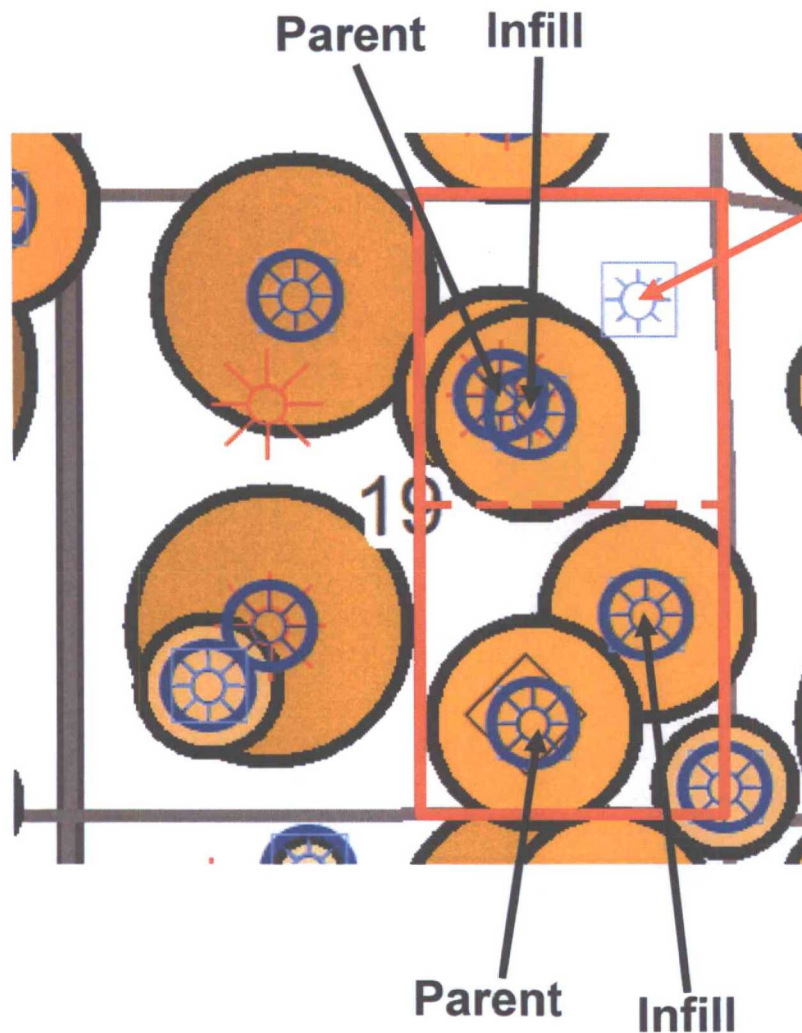

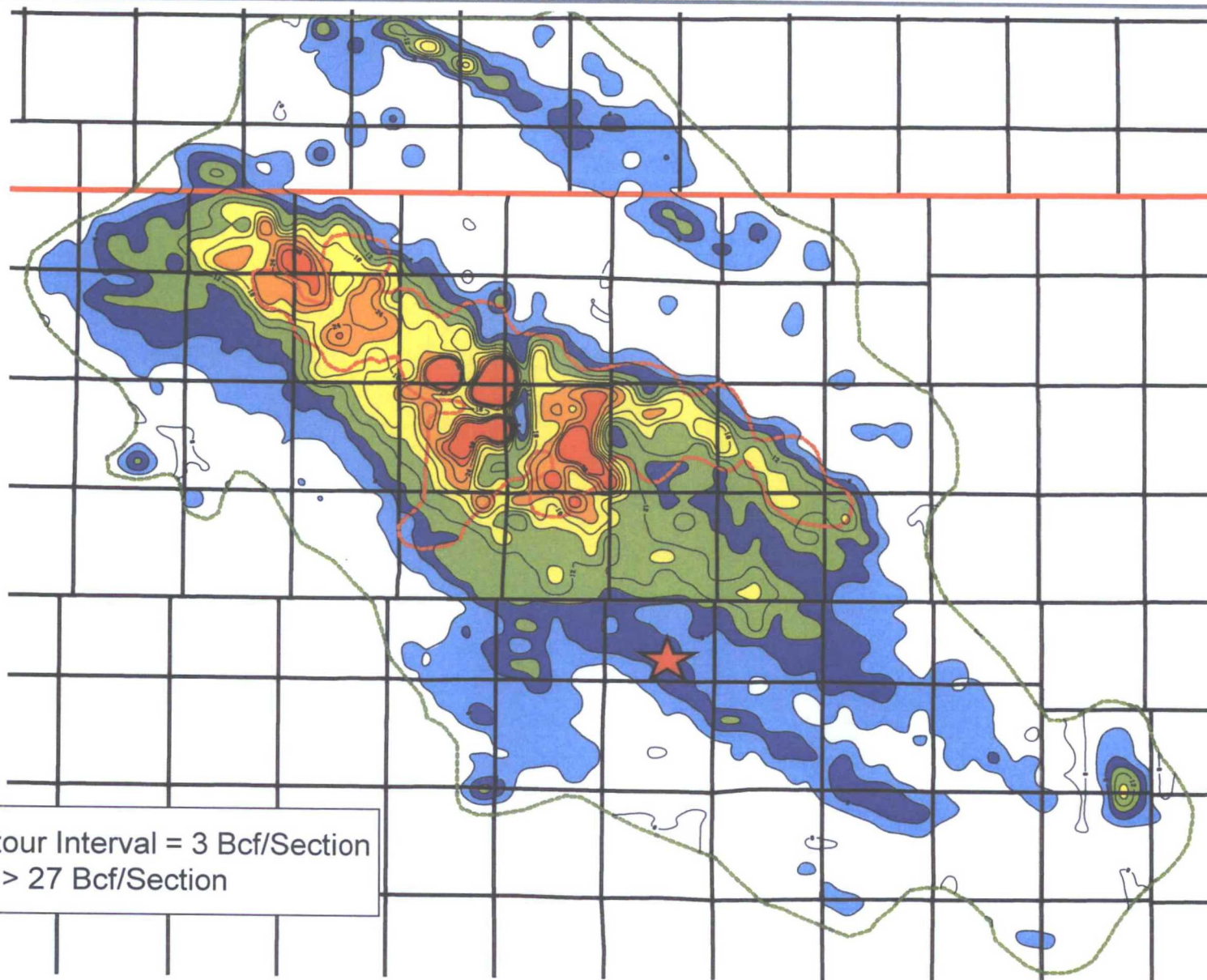


# MV Original Gas-in-Place



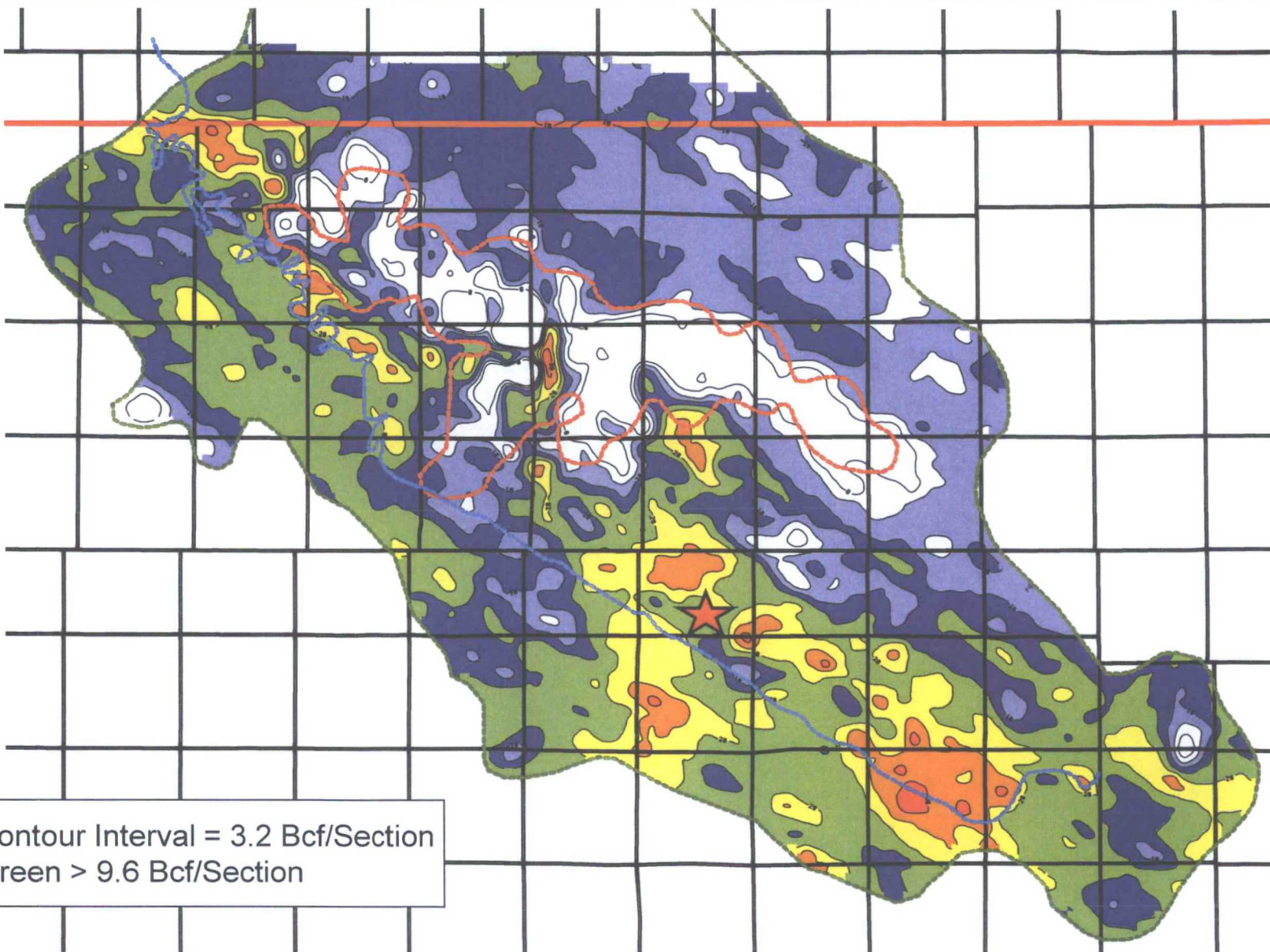


# MV Cumulative Gas Production





# MV Remaining Gas



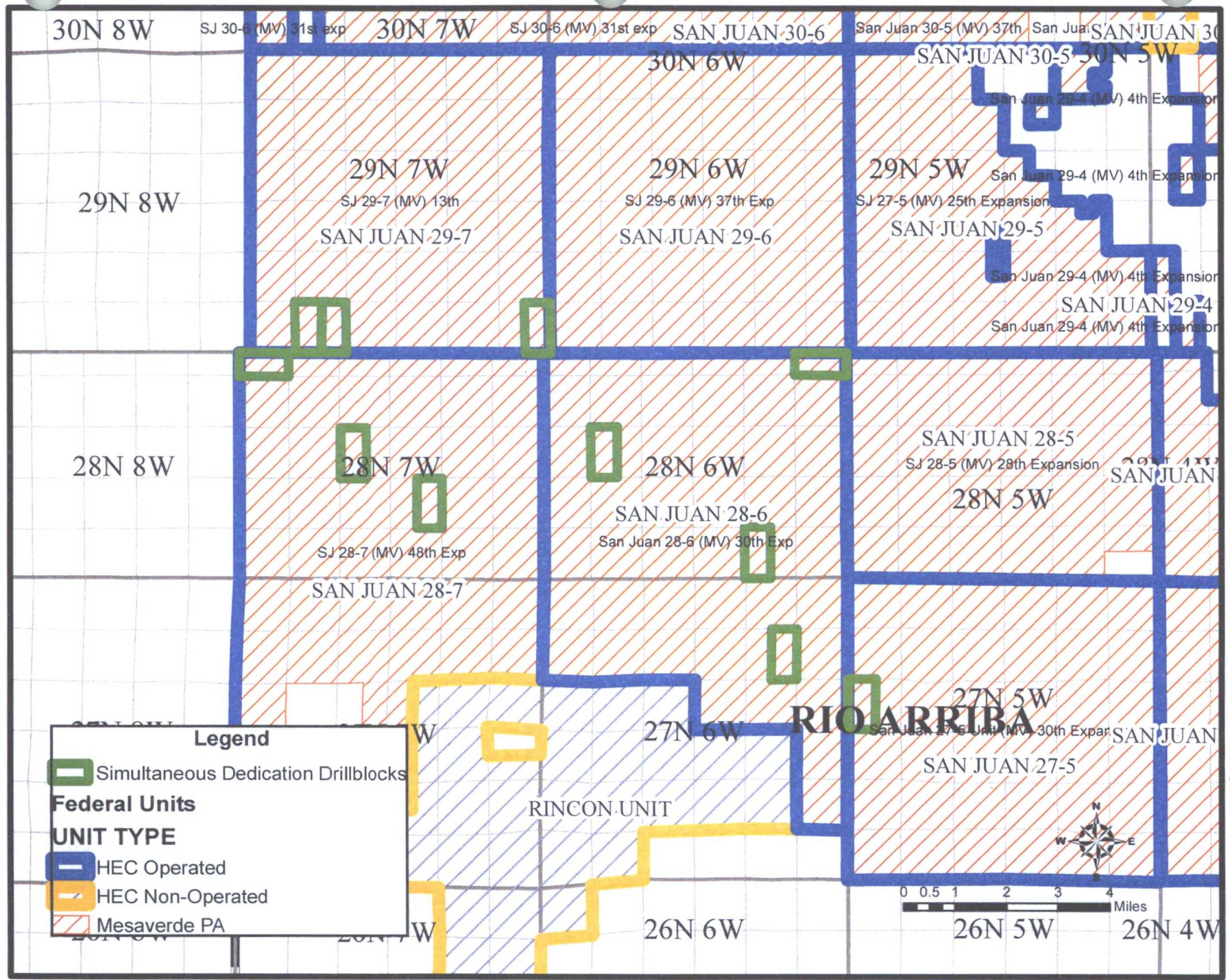

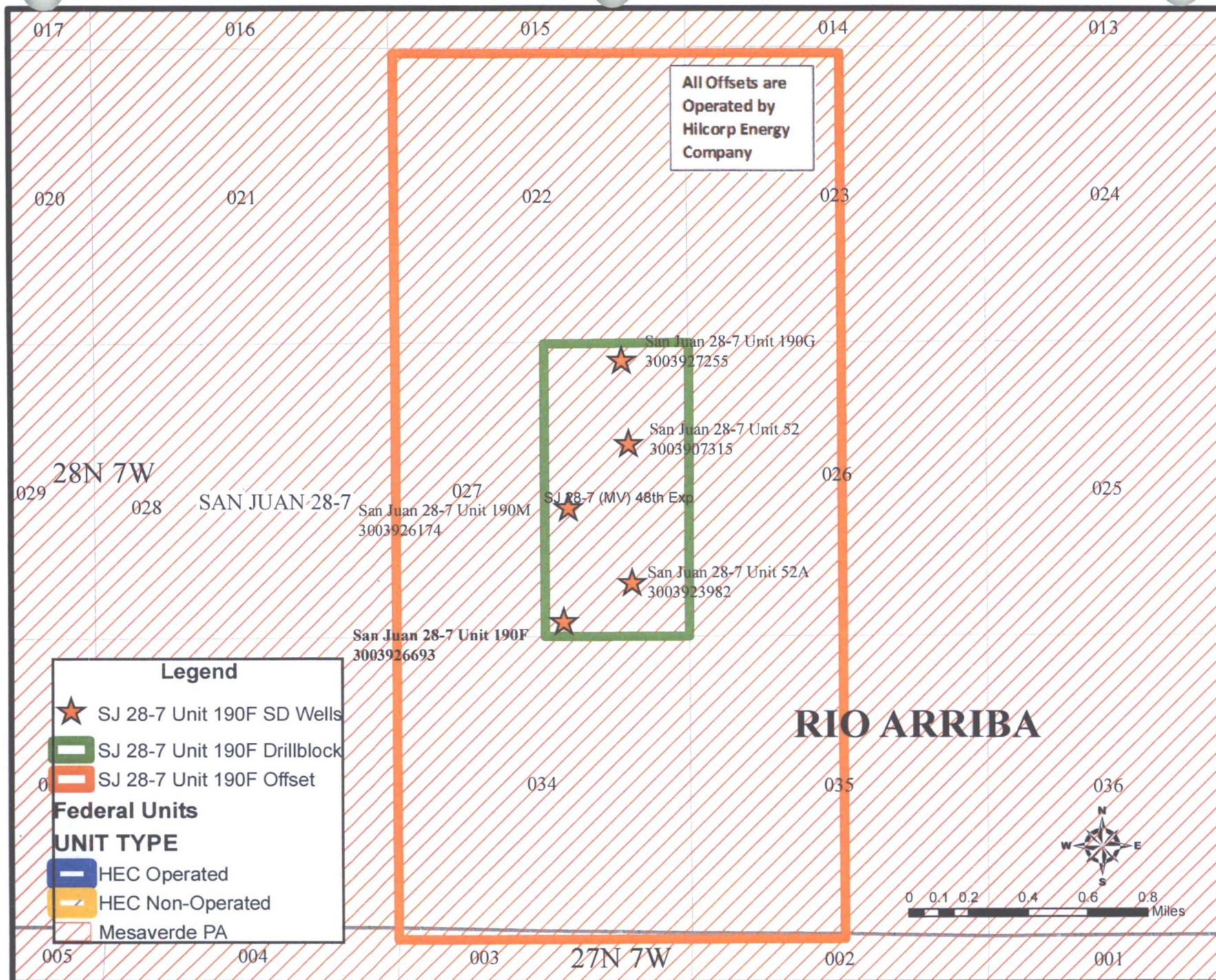
