**STATEMENT OF THE CASE**

These matters involve competing well proposals for development of the Bone Spring formation underlying a proposed non-standard 320-acre spacing and proration unit in the Bone Spring formation comprised of the E/2 W/2 of Sections 20 and 29 in Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. In **Case No. 15926** Mewbourne Oil Company (“Mewbourne”) seeks to develop this acreage with its proposed Caper 20/29 B2CN Fed. Com. Well No. 1H. In **Case No. 15971** Prime Rock seeks to develop this acreage with its proposed Olive Woolly Bugger 20-29 Federal Com #1H to be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of adjacent Section 17 to a standard bottom hole location in the SE/4 SW/4 (Unit N) of Section 29.


