STATEMENT OF THE CASE

OXY seeks an order (1) creating a 319.99-acre non-standard spacing and proration unit comprised of the E/2 E/2 of Section 1 and the E/2 E/2 of Section 12, Township 24 South, Range 30 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Bone Spring formation underlying this acreage. OXY proposes to dedicate the above-referenced spacing and proration unit as the project area for two proposed initial wells, to be drilled and simultaneously completed: the proposed **Nimitz MDP1 "12" Federal Com No. 6H Well** and the proposed **Nimitz MDP1 "12" Federal Com No. 7H Well**. The **Nimitz MDP1 "12" Federal Com No. 6H Well** and the **Nimitz MDP1 "12" Federal Com No. 7H Well** will be pad drilled

horizontally from a surface location in the SE/4 SE/4 (Unit P) of Section 12 to a standard bottom hole location in the NE/4 NE/4 (Lot 1) of Section 1. The completed interval for the each well will remain within the 330-foot standard offsets required by the Statewide Rules set forth in 19.15.15 NMAC. Since these wells will be drilled and simultaneously completed, Oxy requests an extension of the 120-day period provided in the Division's standard pooling order to drill and complete a well.


