APPLICANT'S STATEMENT OF CASE

Percussion seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the S/2 S/2 of Section 32, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted interests in the Red Lake, Glorieta-Yeso

Pool (51120). Percussion proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Red Lake 32 State Com 2H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 32 to a standard bottom hole location in the SW/4 SW/4 (Unit M) of Section 32. The completed interval for this well is closer than 330 feet to the outer boundary of the project area than required by the statewide rules for oil wells and, therefore, is unorthodox to the spacing and proration units to the west and southwest
