**APPLICATION FOR COMPULSORY POOLING, NON-STANDARD
SPACING AND PRORATION UNIT AND NON-STANDARD LOCATION**

EOG RESOURCES INC., applies for an order pooling all mineral interests within the Wolfcamp Formation, non-standard spacing and proration unit, underlying the E/2 of Section 23 and SE/4 of Section 14, Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. In support of this application, Applicant states:

1. Applicant is an interest owner in the E/2 of Section 23 and SE/4 of Section 14, and has the right to drill thereon.
2. Applicant proposes to drill its Haracz 23 Fed Com #715H well to be located at a non-standard well location having a surface location 220 FSL and 343 FEL of Section 23 and a bottom hole location of 2410 FSL and 610 FEL of Section 14, sufficient in depth to test the Wolfcamp Formation.
3. Applicant seeks to dedicate the E/2 of Section 23 and SE/4 of Section 14 to the well to form a non-standard 480 acre spacing and proration unit within the Wolfcamp Formation.
4. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the E/2 of Section 23 and SE/4 of Section 14 for the purposes set forth herein.
5. Certain working interest owners have failed or refused to join in the drilling of the proposed well, therefore, applicant seeks an order pooling all mineral

interest owners in the E/2 of Section 23 and SE/4 of Section 14 pursuant to NMSA 1978, Section 70-2-17 as requested in this application.

6. The pooling of all mineral interests as requested in this application underlying the E/2 of Section 23 and SE/4 of Section 14 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, Applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the E/2 of Section 23 and SE/4 of Section 14 within the Wolfcamp formation.
- B. Approving this application with respect to non-standard spacing and proration unit and unorthodox location.
- C. Designating Applicant as the operator of the well;
- D. Considering the cost of completing the well, and allocating the cost among the well's working interest owners;
- E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and,
- F. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.
