As you are aware Lance Oil & Gas Company ("Lance") has force pooled the referenced lands for Fruitland Coal and Pictured Cliffs development. Lance has offered BP America Production Company ("BP") the opportunity to participate in the No. 2 well under the force pooling order. BP has agreed to participate and paid Lance for the drilling and completion costs in conjunction with the force pooling order. In doing so BP submitted its standard requirements for well information, copy attached. However, Lance has expressed resistance to provide well information and data for future use such as information to conduct production sales nominations. Since Lance is charging an administrative fee to administer BP's account, this should obviously include items such as well information and future volumes for sales nominations. If this matter is not resolved to our satisfaction, BP will request that order R-12451 be opened again to clarify operators duties relative to the overhead charges they will be making to non-operators.
