STATEMENT OF THE CASE

Hilcorp is the operator of a standard 160-acre, more or less, spacing and proration unit, comprised of the NW/4 of Section 23, Township 27 North, Range 10 West, NMPM, San Juan County, New Mexico, which is currently dedicated to the J C Gordon C 1 Well (API No. 30-045-13237) and is producing from the Fulcher Kutz-Pictured Cliffs Gas Pool. The Fulcher Kutz-Pictured Cliffs Gas Pool is governed by Special Rules and Regulations, which provide for 160-acre spacing and proration units. *See* Order No. R-1670, effective April 13, 1960.

Hilcorp is also the operator of the **J C Gordon D 3E Well** (API No. 30-045-24726), which has a surface and bottom hole location 450 feet from the north line, 1580 feet from the west line (Unit C) of Section 23, Township 27 North, Range 10 West, and is currently producing from the Basin Dakota Pool. Hilcorp now proposes to recomplete the **J C Gordon D 3E Well** in the Fulcher Kutz-Pictured Cliffs Gas Pool and dedicate and the well to said spacing and proration unit currently dedicated to the J C Gordon C 1 Well (API No. 30-045-13237).

Hilcorp, therefore, requests that the Division enter an order granting an exception to the well density requirements of the Fulcher Kutz-Pictured Cliffs Gas Pool to authorize Hilcorp to recomplete the **J C Gordon D 3E Well** in the Fulcher Kutz-Pictured Cliffs Gas Pool, permitting the total number of wells dedicated and producing within said spacing and proration unit to two.
