Matador seeks an order from the Division approving expansion of the Northeast Kemnitz Unit. Order R-5232 approved the Northeast Kemnitz Unit Agreement and proposed unit, originally consisting of approximately 3520.0 acres of State land. Order R-5232 approved the unit agreement in principle, which included a unitized interval of all depths. Matador now seeks approval to expand the Unit by approximately 1,760 acres of State lands, as follows:
