Mewbourne Oil Company ("Mewbourne") submits its Pre-Hearing Statement pursuant to the rules of the Oil Conservation Division.

Mewbourne is the applicant in this case. Its business address is 500 West Texas Ave., Suite 1020, Midland, Texas 79701. Mewbourne is represented by the undersigned counsel.

STATEMENT OF THE CASE

Mewbourne's application seeks an order pooling all uncommitted mineral interests in the Wolfcamp formation in a standard 160-acre horizontal spacing unit comprised of the E/2 W/2 of Section 21, Township 26 South, Range 32 East in Lea County, New Mexico. The horizontal spacing unit will be dedicated to Mewbourne's proposed Red Hills West 21 W0CN Fed Com #1H and Red Hills West 21 W1CN Fed Com #2H wells. Both wells will be horizontally drilled from a surface location in Unit C to a bottom hole location in Unit N of Section 21, Township 26 South, Range 32 East. The completed intervals for wells will comply with the Division's setback requirements.


