STATEMENT OF THE CASE

Hilcorp is the operator of a standard 320-acre, more or less, spacing and proration unit in the Blanco-Mesaverde Gas Pool comprised of the S/2 of Section 26, Township 29 North, Range 10 West, San Juan County, New Mexico, in which the following wells are currently completed and producing:

- a. Morris Gas Com C 1 Y Well (API No. 30-045-34738), Sec. 26, T29N, R10W (Unit N);
- b. Abrams L 1 Well (API No. 30-045-25670), Sec. 26, T29N, R10W (Unit M); and
- c. Abrams L 1A Well (API No. 30-045-25616), Sec. 26, T29N, R10W (Unit I).

The Blanco-Mesaverde Gas Pool is governed by Special Rules and Regulations, which provide for 320-acre spacing and proration units and four wells per spacing unit. *See* Order No. R-8170, as superseded by Order No. R-10987-A, and amended by Order No. R-10987-A(1), effective Dec. 2, 2002.

Hilcorp now proposes to simultaneously dedicate and produce the following fourth well within the same standard spacing and proration unit, at the following location, requiring an order authorizing an exception to the Special Rules:

- a. **Morris Gas Com C 1E Well** (API No. 30-045-23567), Sec. 26, T29N, R10W (Unit I).

Hilcorp therefore requests that the Division enter an order granting an exception to the well density requirements of Rule 1.B of the Special Rules of the Blanco-Mesaverde Pool to authorize Hilcorp to simultaneously dedicate and produce the **Morris Gas Com C 1E Well** (API No. 30-

045-23567) within the S/2 of Section 26, Township 29 North, Range 10 West, permitting two wells to be completed in the same quarter-quarter section (Unit I) within the same standard spacing and proration unit.


