**APPLICATION OF KAISER-FRANCIS OIL
COMPANY FOR COMPULSORY POOLING,
EDDY COUNTY, NEW MEXICO.**

APPLICATION

Kaiser-Francis Oil Company applies for an order pooling all mineral interests in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2N/2 of Section 24, Township 23 South, Range 28 East, N.M.P.M. and the S/2N/2 of Section 19, Township 23 South, Range 29 East, N.M.P.M., and in support thereof, states:


1. Applicant is an interest owner in the S/2N/2 of Section 24 and the S/2N/2 of Section 19, and has the right to drill a well thereon.
2. Applicant proposes to drill the Mosaic Fed. 2419 3BS Well No. 2H and to dedicate the S/2N/2 of Section 24 and the S/2N/2 of Section 19 to the well. The well has a first take point in the SW/4NW/4 of Section 24, and a final take point in the SE/4NE/4 of Section 19.
3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the Bone Spring formation underlying the S/2N/2 of Section 24 and the S/2N/2 of Section 19 for the purposes set forth herein.
4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in the Bone Spring formation in the S/2N/2 of Section 24 and the S/2N/2 of Section 19, pursuant to NMSA 1978 §70-2-17.

5. The pooling of all mineral interests in the Bone Spring formation underlying the S/2N/2 of Section 24 and the S/2N/2 of Section 19 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the Bone Spring formation underlying the S/2N/2 of Section 24 and the S/2N/2 of Section 19;
- B. Designating applicant as operator of the well;
- C. Considering the cost of drilling and completing the well, and allocating the cost thereof among the well's working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.

Application of Kaiser-Francis Oil Company for compulsory pooling, Eddy County, New Mexico. Kaiser-Francis Oil Company seeks an order pooling all mineral interests in the Bone Spring formation in a horizontal spacing unit underlying the S/2N/2 of Section 24, Township 23 South, Range 28 East, NMPM and the S/2N/2 of Section 19, Township 23 South, Range 29 East, NMPM. The unit will be dedicated to the Mosaic Fed. 2419 3BS Well No. 2H, with a first take point in the SW/4NW/4 of Section 24 and a final take point in the SE/4NE/4 of Section 19. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located 4 miles southwest of Malaga, New Mexico.
