Lime Rock Resources II-A, L.P. ("Lime Rock") submits this Amended Pre-Hearing Statement pursuant to the rules of the Oil Conservation Division.

**STATEMENT OF THE CASE**

Lime Rock's application seeks an order pooling all uncommitted mineral interests in the Yeso formation in a standard 200-acre horizontal spacing unit comprised of the N/2 S/2 of Section 11 and the NW/4 SW/4 of Section 12, Township 18 South, Range 26 East, NMPM, in Eddy County. Lime Rock proposes to dedicate the horizontal spacing unit to the Brainard 12 #2H well, which will be horizontally drilled from a surface location in Unit K in Section 12 to a last take point in Unit L in Section 11, Township 18 South, Range 26 East.


