**APPLICANT'S STATEMENT OF CASES**

Ameredev seeks an Order pooling all uncommitted interest in the Wolfcamp formation in the 640-acre spacing unit comprised of the E/2 W/2 of Sections 15 and 22 and the W/2 E/2 of Sections 15 and 22, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico. Ameredev proposes to dedicate the above-referenced spacing unit to the proposed **Magnolia State Com 26 36 22 No. 125H Well**. This well will be horizontally drilled from a surface

location in the SW/4SE/4 (Unit O) of Section 22 to a bottom hole location in the NW/4NE/4 (Unit B) of Section 15. Pursuant to NMAC 19.15.16.15(B)(1)(b), Ameredev will incorporate the proximity tracts into its horizontal spacing unit. Incorporating the proximity tracts, the completed interval for the well will remain within the standard offset required by the statewide rules set forth in 19.15.15 NMAC.
