

Page 2 1 (9:18 a.m.) CHAIRWOMAN RILEY: Okay. Moving to item 2 five, Case Number 15959, rulemaking, this has been 3 continued from June 5th through the 7th Commission 4 meeting, and it's the application of the New Mexico Oil 5 Conservation Division to repeal and replace Rule 6 7 19.15.29. 8 At this point we need to decide if there is any further deliberation and possibly adopt the rule. 9 10 MR. BRANCARD: So, Commissioners, I've 11 forwarded to you and you have in your packets also the, sort of, final version of Rule 19.15.29 with all the 12 changes the Commission approved during deliberations two 13 weeks ago, and we've also had the State Records 14 administrator review it. So it's pretty much in the 15 final version that could be filed. 16 And the second document that you have is a 17 18 draft order for this case for your review and possible 19 approval. 20 COMMISSIONER BALCH: I went through this and maybe I missed it the first time through, but I 21 recall that we were going to direct some changes on a 22 23 couple of OCD forms in the order. MR. BRANCARD: So I sent you-all two 24 The second version, if you go all the way to 25 versions.

Page 3 the last page -- I recall the same thing. I forgot 1 2 initially, and I sent a second version. If you go all 3 the way to the second page --COMMISSIONER BALCH: There we go. All 4 5 right. MR. BRANCARD: -- it's actually in ordering 6 7 paragraph two. COMMISSIONER BALCH: Good. 8 9 I think I would move to adopt the order in 10 the rule as presented. COMMISSIONER MARTIN: Second. 11 CHAIRWOMAN RILEY: So it's been moved and 12 seconded to adopt the order as presented in the rule 13 with its changes and edits. So that has now occurred. 14 15 COMMISSIONER BALCH: Do we have to do a 16 voice vote on that? 17 MR. BRANCARD: Yeah. Do a voice vote. CHAIRWOMAN RILEY: I'm sorry? 18 19 MR. BRANCARD: Do a voice vote. CHAIRWOMAN RILEY: Oh. Can I have a voice 20 21 vote on this adoption? MR. BRANCARD: All in favor? 22 23 (Ayes are unanimous.) MR. BRANCARD: So the schedule, as you're 24 aware, is that we then wait 20 days for any requests for 25

Page 4 a rehearing, and then once that is done, then we will file the rule with the State Records administrator, and they will publish it in the next version of the "New Mexico Register." Following that filing and upon publication, the rule becomes effective. (The proceedings conclude, 9:22 a.m.)
