




Ladies and gentlemen:





To: DSD Energy Resources, LLC, Marathon Oil Permian LLC, V-F Petroleum, Inc., and Isaac Archuleta, or your successors or assigns: Matorador Production Company has filed an application with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests in the Bone Spring formation underlying the E/2E/2 of Section 1 and the E/2E/2 of Section 12, Township 23 South, Range 27 East, NMPM. The unit will be dedicated to the Larry Wolfish 1&12-23S-27E RB Well No. 124H, a horizontal well with a surface location in the SE/4SE/4 of Section 36, Township 22 South, Range 27 East, N.M.P.M., a first take point in the NE/4NE/4 of Section 1, and a last take point in the SE/4SE/4 of Section 12. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
