
Ladies and gentlemen:



Calland, or your heirs, devisees, successors, or assigns: Mewbourne Oil Company has filed an application with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2NE/4 of Section 29 and the S/2N/2 of Section 28, Township 18 South, Range 29 East, NMPM. The unit will be dedicated to the Pavo Frio 29/28 B2GH Fed. Com. Well No. 1H, with a first take point in the SW/4NE/4 of Section 29 and a final take point in the SE/4NE/4 of Section 28. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, April 4, 2019 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505.
