- 2. I am a geologist for Matador Production Company, and I am familiar with the geological matters involved in this case. I have been qualified by the Division as an expert petroleum geologist.
- 3. Attachment A is a locator map.
  - 3. The following geological plats are attached hereto:
  - (s) Attachment B is a structure map on the top of the Wolfcamp formation. It shows that structure dips gently to the east. It also shows a line of cross-section.
  - (b) Attachment C is a west-east cross section. The logs on the cross-section give a representative sample of the Wolfcamp formation in this area. The target zone for the well, shown on the plat, is the top of the Wolfcamp. The zone is continuous across the well unit.
  - 4. I conclude from the exhibits that:
  - (a) The horizontal spacing unit is justified from a geologic standpoint.
  - (b) Each quarter section in the unit will contribute more or less equally to production.
  - (c) There is no faulting or other geologic impediment on the area which will adversely affect the drilling of the subject wells.
  - 5. There is no preference is for standup or laydown well units in this area.




