APPLICANT'S STATEMENT OF CASE

In this case WPX seeks an order (1) pooling all uncommitted interests in the Wolfcamp formation (Purple Sage Wolfcamp Gas Pool (98220)) underlying a 640-acre standard horizontal spacing unit comprised of S/2 of Section 34 and 35, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico, and (2) dedicating the above-referenced horizontal spacing unit to the proposed **Beagle 35-34-22-27 Fee 401H** well to be drilled from a surface hole location in NW/4 SW/4 (Unit L) of Section 36 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 34.

The completed interval for the proposed well will comply with the setback requirements imposed by the Special Rules for the Purple Sage Wolfcamp Gas Pool set forth in Order No. R-14262.
