Applicant Marathon Oil Permian, LLC ("Marathon") seeks an order pooling all uncommitted mineral interests within a Wolfcamp horizontal spacing unit underlying the W/2 of Section 22, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.

Marathon seeks to dedicate the W/2 of Section 22, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico, to form a 320-acre, more or less, spacing unit.

In this proposed unit, Marathon plans to drill eight horizontal wells within the Purple Sage Wolfcamp Gas Pool, pool code 98220, including the Honey Mustard Federal Com WA 2H, Honey Mustard Federal Com WD 3H, Honey Mustard Federal Com WD 5H, Honey Mustard Federal Com WXY 6H, Honey Mustard Federal Com WXY 8H, Honey Mustard Federal Com WA 9H, Honey Mustard Federal Com WD 10H & Honey Mustard Federal Com WD 11H wells, to a depth sufficient to test the Wolfcamp formation.

S.K. Warren Resources, LLC is owner of an interest in these proposed wells. SK Warren would like to participate in development of this acreage, but is concerned that the cost of participation will be prohibitive due to the number of proposed wells. Among other things, SK Warren further questions whether eight proposed wells are necessary to develop this acreage.
