APPLICANT'S STATEMENT OF CASE

Centennial (OGRID No. 372165) seeks an order pooling all uncommitted interests in the Bone Spring formation (Bilbrey Basin; Bone Spring (5695)) underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 W/2 of Section 32, Township 21 South, Range 32 East, and the E/2 W/2 of Section 5, Township 22 South, Range 32 East, NMPM, Lea County, New Mexico. Centennial proposes to dedicate the above-referenced spacing unit to the **Cheddar Fed Com No. 602H Well**, which will be horizontally drilled from a surface location in the SW/4

SW/4 (Unit M) of Section 5, T22S, R32E, to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 32, T21S, R32E. The completed interval for this well will comply with the Statewide setback requirements for oil wells.


