APPLICANT'S STATEMENT OF CASE

Centennial (OGRID No. 372165) seeks an order pooling all uncommitted interests in the Bone Spring formation (Ojo Chiso; Bone Spring, South (97293)) underlying a standard 240-acre, more or less, horizontal spacing unit comprised of the W/2 W/2 of Section 9 and the W/2 NW/4 of Section 16, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico. Centennial proposes to dedicate the above-referenced spacing unit to the **Hagberry 9 State Com No. 501H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of

Section 9 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 16. The completed interval for this well will comply with the Statewide setback requirements for oil wells.
