APPLICANT'S STATEMENT OF THE CASE

Devon seeks an order pooling all uncommitted interests in the Bone Spring formation (Winchester; Bone Spring (65010) & Parkway; Bone Spring (49622)) underlying a standard 480-

acre, more or less, horizontal spacing unit comprised of the N/2 of Section 32 and the NW/4 of Section 33, Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico. This spacing unit will be dedicated to the following proposed wells:

- **Uraninite 32-33 State Fed Com 332H Well** to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 32 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 33.
- **Uraninite 32-33 State Fed Com 333H Well** to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 32 to a bottom hole location in the SE/4 NW/4 (Unit F) of Section 33.

The completed interval for the Uraninite 32-33 State Fed Com 332H Well will remain within 330 feet of the S/2 N/2 of Sections 32 and 33 to allow inclusion of these proximity tracts in a standard 480-acre horizontal spacing unit comprised of the N/2 of Section 32 and the NW/4 of Section 33.
