Regeneration seeks an order approving its Blood Moon State Unit. The proposed Unit Area for the Blood Moon Unit consists of the following 640 acres of State land situated in Eddy County ("Unit Area"):

**TOWNSHIP 26 SOUTH, RANGE 27 EAST, NMPM**

Section 16: All

Regeneration is the designated operator under the Unit Agreement and anticipates reaching agreement with all working interest owners in the Unit Area. The unitized interval is from the

surface down to the stratigraphic equivalent of the base of the Delaware formation at a measured depth of approximately 5,270 feet.


