



Purple Sage; Wolfcamp (Gas) (Pool Code 98220) Locator Map

Purple Sage; Wolfcamp (Gas) (Pool Code 98220) Structure Map (Top Wolfcamp Subsea)








Purple Sage; Wolfcamp (Gas) (Pool Code 98220) Structural Cross Section A - A'


