1	WHEREUPON, the following proceedings were had at
2	2:23 p.m.:
3	EXAMINER JONES: And at this time we'll call Case
4	13,713, Application of the New Mexico Oil Conservation
5	Division for an order requiring the Estate of Reuben F.
6	Momsen to plug one well and ordering forfeiture of
7	applicable financial assurance in event of operator's
8	noncompliance, Eddy County, New Mexico.
9	Call for appearances.
10	MR. BROOKS: Mr. Examiner, David Brooks for the
11	OCD.
12	EXAMINER JONES: No other appearances.
13	MR. BROOKS: I have one witness, the same witness
14	as in the previous two cases.
15	EXAMINER JONES: Okay.
16	MR. BROOKS: Mr. Examiner, you mentioned the name
17	and there is some confusion about this. The name is shown
18	on the computer as Reuben F. Monsen, M-o-n-s-e-n. However,
19	numerous documents in the file show the name as Reuben F.
20	Momsen, M-o-m-s-e-n, and I don't have any authoritative
21	means of determining what the correct spelling of that name
22	is. It's shown different ways on different documents in
23	the OCD file. I would perhaps suggest that the order say
24	Monsen or Momsen.
25	In this case I'll call your attention to what has

1	been marked as OCD Exhibit 1. This is the well list. It
2	identifies the only well allegedly operated by Reuben F.
3	Monsen or Momsen. The date of last production is or
4	injection is shown as 5 of '87.
5	Call your attention to Exhibit Number 2. Exhibit
6	Number 2 is a letter by the OCD dated January 14th of 1954,
7	in which Reuben F. Momsen or Monsen was I believe it
8	says Momsen on this letter, although it's so smeared in
9	this copy I can't tell was recognized as operator of
10	this well.
11	Pass over Exhibit Number 3, call your attention
12	to OCD Exhibit Number 4, which is a letter to Reuben F.
13	Momsen's surety, American Employers Insurance Corporation.
14	We noted in that letter that since we had no address for
15	Reuben F for the estate of Reuben F. Momsen, that we
16	did not attempt other than published service upon the
17	estate, but we were giving personal notification to the
18	surety. And attached thereto is the surety's return
19	receipt, indicating receipt thereof.
20	Then call your attention to Exhibit Number 5,
21	which is a copy of American Employers Insurance Company's
22	bond number A-E-71334-40, in the amount of \$5000, relating
23	to and we can't absolutely be sure of the identity of
24	the wells since they give only a quarter quarter section
25	unit, and they don't give the footages. However, it does

1	appear to be in the correct quarter quarter section. Let's
2	see, it's in the southwest of the northeast, and I believe
3	if you count all the A, B, C, D, E, F, G, the G, which is
4	where it's shown on the well list, would be in the
5	southwest of the northeast. So we are presuming that this
6	is the correct well, although the lack of a precise
7	description on the bond raises some question on that.
8	Finally, call your attention to OCD Exhibit
9	Number 6, which again is a copy of the affidavit of
10	publication showing that notice of this hearing was
11	published for May 11th in the Artesia Daily Press, and we
12	believe the record will reflect that this was continued
13	from May 11th to this date. And this is the second in the
14	second column, and now, the address is shown as Momsen
15	in the notice, and if the real name is Monsen,
16	M-o-n-s-e-n, we may have a notice problem. However, I
17	believe that the actual older records in the OCD file, well
18	file, which are probably more likely to be correct, use the
19	M-o-m-s-e-n spelling. There's no question of there being
20	two operators, because there's only one OGRID number, so it
21	was submitted on that basis.
22	And with that I will offer in evidence Exhibits
23	Numbers 1, 2, 3, 4 I'm sorry, 1, 2, 4, 5 and 6.
24	EXAMINER JONES: Exhibits Number 1, 2, 4, 5, and
25	6 will be admitted.

1	<u>VAN BARTON</u> (Present by telephone),
2	the witness herein, having been previously duly sworn upon
3	his oath, was examined and testified as follows:
4	DIRECT EXAMINATION
5	BY MR. BROOKS:
6	Q. Okay, Mr. Barton
7	A. Yes, sir.
8	Q if I ask you about your name, employment and
9	credentials, would they be the same as they were in the
10	last two cases?
11	A. They would, sir.
12	Q. Okay. Are you familiar with the North State Well
13	Number 1, what was at one time operated by Reuben Momsen or
14	Monsen?
15	A. Yes, sir.
16	Q. Do you have any light to shed on the correct
17	spelling of this name?
18	A. No, sir. Some of the earlier records from the
19	early 1950s show an M-o-m-s-e-n. However, in the P-and-A
20	procedures that was prepared, the M-o-n-s-e-n last name
21	spelling was used because that's the way it was spelled in
22	our RBDMS database.
23	Q. Now, you said the older records is it correct
24	that the older records show the M-o-m-s-e-n spelling?
25	A. Yes, sir. In 1954 there is a certificate of

1	compliance and authorization to transport oil and gas, and
2	it's the operator is a Reuben F. M-o-m-s-e-n.
3	Q. Okay, thank you.
4	You prepared this plugging or did you or
5	someone under your supervision prepare plugging procedure
6	reflected on Exhibit Number 3?
7	A. Yes, sir.
8	Q. And if the North State Well Number 1 were plugged
9	in accordance with that plugging procedure, would it be
10	properly plugged and abandoned in accordance with OCD
11	Rules?
12	A. Yes, sir.
13	Q. In your examination of the well file for this
14	well, did you find any evidence that this well was in
15	temporary abandonment status? Approved temporary
16	abandonment status?
17	A. This well did not I did not find any evidence
18	that this well is in temporary abandonment status.
19	MR. BROOKS: Very good, thank you. With that, I
20	will tender Exhibit Number 3.
21	EXAMINER JONES: Exhibit Number 3 will be
22	admitted.
23	MR. BROOKS: And I pass the witness.
24	EXAMINER JONES: I have no questions.
25	MS. MacQUESTEN: I just have one question for Mr.

1	Brooks. On trying to get in touch with the estate of
2	Reuben Momsen, did you try to serve the estate using the
3	address listed on the bond?
4	MR. BROOKS: No, we did not.
5	MS. MacQUESTEN: I don't know enough about
6	estates and how long they last to know whether it would
7	have done any good. Do you know if
8	MR. BROOKS: I have no idea, Ms. MacQuesten,
9	whether it would have or not. I do know that this from
10	the files, the documents in the file, that documents on
11	this well have been filed in the name of the estate as far
12	back as the 1980s, so it's apparent that Reuben F. Momsen
13	must have died at least 20 years ago, but that's all the
14	information.
15	Because of the fact that this was so old and I
16	couldn't find any addresses, that I don't see an address
17	on the bond. Is there Is there an address on the bond?
18	I don't
19	MS. MacQUESTEN: On the second page, the bond is
20	actually
21	MR. BROOKS: Oh, the State National Bank of El
22	Paso
23	MS. MacQUESTEN: Right.
24	MR. BROOKS: Yes.
25	MS. MacQUESTEN: Right, as trust officer.

MR. BROOKS: No, I did not make any effort to 1 contact the successor of that bank, which I'm not even sure 2 which -- I know that the State National Bank of El Paso was 3 -- became part of the M Bank system, and then when the M 4 bank system went under it became independent again, and 5 6 then it merged with some other conglomerate, but I forget which one. And I did not make any attempt to contact the 7 successor to that bank. 8 MS. MacQUESTEN: Are you suggesting that this 9 address that was given back in 1977 may no longer be --10 MR. BROOKS: I'm --11 MS. MacQUESTEN: -- useful to us? 12 (Laughter) 13 MR. BROOKS: Yes, that is probably not going to 14 produce much. 15 That's all I have. 16 MS. MacQUESTEN: 17 EXAMINER JONES: Thank you.
