STATEMENT OF THE CASE

OPPONENT:

Chesapeake will submit evidence to demonstrate that WJP Exploration, LLC ("WJP") has prematurely included it in this compulsory pooling case. On February 24, 2006 Chesapeake advised Capstone Oil & Gas Company, the original proposing party, that Chesapeake would participate in the drilling of this well. On May 15, 2006, Mr. Bruce on behalf of WJP sent notice of the June 8, 2006 hearing date to Chesapeake.
