1 WHEREUPON, the following proceedings were had at  
2 10:25 a.m.:

3 CHAIRMAN FESMIRE: The next item on the agenda is  
4 Case Number 13,486. It's the Application of Synergy  
5 Operating, LLC, for compulsory pooling in San Juan County,  
6 New Mexico. This case has been continued from the  
7 September 15th, 2005, Commission meeting, and at the  
8 request of counsel the case will be continued until the  
9 January 12th, 2006, Commission meeting.

10 The next case is Case Number 13,274, the  
11 Application of Arch Petroleum, Inc., for approval of two  
12 nonstandard gas spacing and proration units in the Jalmat  
13 Gas Pool in Lea County, New Mexico. This case has been  
14 readvertised and continued from the October 13th, 2005,  
15 Commission meeting. The case will be continued to the  
16 December 8th, 2005, Commission meeting.

17 The next case on the docket is Case Number  
18 13,480. It's a *de novo* hearing on the Application of Gandy  
19 Marley, Inc., to modify their existing NMOC Rule 711  
20 Permit Number NM-01-019 so that they may accept salt-  
21 contaminated oilfield wastes. This case will be continued  
22 to the January 12th, 2006, Commission meeting.

23 The next case is Case Number 13,367, *de novo*  
24 Application of Bass Enterprises Production Company for an  
25 order authorizing the drilling of a well in the potash area

1 in Eddy County, New Mexico. This case will be continued to  
2 the January 12th, 2006, Commission meeting.

3 The next case is Case Number 13,368, the  
4 Application of Devon Energy Production, L.P. -- L.P., not  
5 L.L.P. -- for an order authorizing the drilling of a well  
6 in the potash area, Eddy County, New Mexico. This case  
7 will also be continued to the January 12th, 2006,  
8 Commission meeting.

9 The next case is Case Number 13,372, the  
10 Application of Devon Energy Production, L.P., for approval  
11 of an unorthodox well location and authorization to drill a  
12 well in the potash area of Eddy County, New Mexico. This  
13 case will be continued to the January 12th, 2006,  
14 Commission meeting.

15 The next case is Case Number 13,589, the  
16 Application of Duke Energy Field Services, LP, for approval  
17 of an acid gas injection well in Lea County, New Mexico.  
18 And this case has been continued to the December 8th, 2005,  
19 Commission meeting. To the December 8th? We agreed on the  
20 December 8th?

21 MR. CARR: Yes, sir, only for the purpose of  
22 figuring out where we are at that time.

23 CHAIRMAN FESMIRE: Okay, all right.

24 Is there any further business before the  
25 Commission today?

1 With that, I think the Chair will entertain a  
2 motion to adjourn.

3 COMMISSIONER BAILEY: I so move.

4 COMMISSIONER OLSON: Second.


