STATEMENT OF CASE

APPLICANT

Applicant seeks an order approving the drilling of its proposed James Ranch Unit Well No. 93 within the Potash Area at a location 660 feet from the North and East lines (Unit A) of Section 7, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico. This well will be drilled to an approximate depth of 14,800 to test all formations from the surface to the base of the Morrow formation, Los Medanos-Morrow Gas Pool and will be at a standard location in all formations. Said location is within the Potash Area and approximately 10 miles east of Carlsbad, New Mexico.

Mr. Bailey will review Bass Enterprises Production Co.'s efforts to develop the oil and gas minerals under the 40-acre tract comprised of the NE/4 NE/4 of Section 7, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico. Mr. Bailey's testimony will show that Bass holds the oil and gas lease on the tract on which it proposes to drill. He will show that, pursuant to the provisions of Order No. R-111-P, Bass has reached agreement with the owners of the potash rights under these lands and all of these owners desire to have their oil and gas minerals developed prior to the potash reserves, if any. Bass filed its APD for this well and pursuant to Order No. R-111-P notified all potash lessees within one mile. No objection was timely filed and Bass' APD was approved. Thereafter IMC (now Mosaic Potash) wrote the Division and objected to the well because its location falls in an LMR (area designated as containing Life of Mine Reserves).

Mr. Bailey's testimony will show that Mosaic owns no potash rights in this tract and that Mosaic is asking the Commission to deny the owners of the oil and gas minerals and the potash reserves the right to develop their constitutionally protected property rights.

Mr. Bailey will ask the Commission to approve its application and find, as the Division has on several prior occasions, that:

A. "Order No. R-111-P makes no provision for an LMR determination when the proposed well is located on fee lands, nor does Order No. R-111-P authorize a potash lessee to designate an LMR over lands not leased to a potash lessee;"

B. "Sub-part G (e) 3 of these rules, provides that 'application to drill in the LMR area, including buffer zones, may be approved only by mutual agreement of the lessor and lessees of both potash and oil and gas interests;'" and

C. That the surface and all mineral owners have consented to the proposed well and desire to have their oil and gas minerals developed first in preference to any potash reserves underlying the subject acreage.

William R. Daniels (Engineer) Approximately 5 Minutes 1


Mr. Daniels will testify briefly and show that the proposed casing and cementing program for the well meets the criteria established by Order No. R-111-P.

Stacy Mills (Mineral Owner) Approximately 10 Minutes None

Mr. Mills will appear and testify that he is an owner of the mineral estate, including potash rights, under the subject spacing unit. He will confirm that the oil and gas rights under this tract have been leased to Bass and that an agreement has been reached between the mineral owners and Bass for the development of their oil and gas minerals before the potash resources, if any, are mined. He will testify that the oil and gas rights under this tract have been leased to oil companies for over 20 years and to date, no minerals, either oil and gas or potash, have been produced from these lands.

PROCEDURAL MATTERS

Bass Enterprises Production Co. will request that this case and Cases No. 13368 and 13372 be consolidated for the purposed of hearing.


