4	use the gavel on this glass, so we'll just go ahead and get

6	It's January 21st, year 2000, our first meeting

9	Industries Division was meeting in the Oil Conservation

13	person here, so I'll introduce everybody. I'm the Director
14	of the Oil Conservation Division and Chairman of the Oil

18	Powell, on the Oil Conservation Commission.
19	And to my left is Commissioner Robert Lee.
20	Robert Lee heads up the Petroleum Recovery Research Center
21	at New Mexico Tech, and he is Secretary Salisbury's
22	appointee to the Oil Conservation Commission.
23	We also have Lyn Hebert, the Commission's legal

meetings as well as Division hearings. 1 Also, I might introduce everybody to Cheryl 2 Baca --3 MS. BADA: Bada. 4 CHAIRMAN WROTENBERY: Bada --5 MS. BADA: Bada. 6 CHAIRMAN WROTENBERY: Bada. -- who is the 7 Department's newest attorney, just started this week or 8 last week? This week? We're very glad to have her here. 9 I hope she'll be doing some work for the Oil Conservation 10 Division at some point. We look forward to working with 11 12 you. We've got, I think, a fairly brief agenda today. 13 I don't know of any preliminary matters that we need to 14 attend to, so we might just go ahead and run through some 15 of these business items. 16 17 First of all, we've got the minutes of two prior Commission meetings, the meeting held on November 17th, 18 19 1999, and the meeting held on December 17th, 1999. 20 Commissioners, have you had a chance to review --COMMISSIONER BAILEY: 21 Yes. 22 CHAIRMAN WROTENBERY: -- the draft of these 23 minutes? 24 COMMISSIONER LEE: (Nods) 25 CHAIRMAN WROTENBERY: I'll entertain a motion to

adopt both sets of minutes. 1 COMMISSIONER BAILEY: I move that we adopt both 2 3 sets. COMMISSIONER LEE: Second. 4 CHAIRMAN WROTENBERY: All in favor say "aye". 5 COMMISSIONER BAILEY: 6 Aye. 7 COMMISSIONER LEE: Aye. CHAIRMAN WROTENBERY: Aye. Okay, I've got these 8 here to sign on behalf of the Commission. Thank you, 9 10 Florene. 11 * 12 CHAIRMAN WROTENBERY: And next item is our annual 13 Open Meetings Act resolution. Lyn, would you like to lay 14 that one out for us? 15 MS. HEBERT: Every year in January the Commission 16 17 adopts a resolution that describes the notice that will be given for the Commission meetings, and the Commission does 18 19 this pursuant to the Open Meetings Act that requires you to 20 adopt such a resolution every year. 21 This is the same resolution that was adopted last 22 year, with one exception, the number of days of notice: 23 The regular meetings have ten days' notice, the special meetings three days' notice, and emergency meetings can be 24 held on 24 hours' notice. 25

1	The only change we made to this resolution was,
2	it no longer recites that a regular monthly meeting will be
3	held on Thursday, because the meetings have been moving
4	around some in the last year, so we just indicated that a
5	regular monthly meeting will be held and gave the address
6	and the fact that it will be noticed, when that meeting
7	will be. And that's the only change.
8	CHAIRMAN WROTENBERY: Any questions for Lyn?
9	Okay, I'll entertain a motion, that we adopt
10	COMMISSIONER BAILEY: I so move.
11	CHAIRMAN WROTENBERY: the resolution.
12	COMMISSIONER LEE: Second.
13	CHAIRMAN WROTENBERY: All in favor say "aye".

Landreth for a determination of reasonable 12 13 well costs for a well in Lea County, New Mexico. This is 14 Case 12,008. And here too we had a request from the 15 Applicant, Robert E. Landreth, that we continue the 16 hearing. In this instance, the Applicant is requesting 17 that this Application be rescheduled for the Commission's meeting on March 24th, 2000, so we'll see that case again 18 19 in a couple of months. 20 (Thereupon, these proceedings were concluded at 9:22 a.m.) 21 22 * * 23 24 25
