

Dear Ms. Vierra:

This office has reviewed the unexecuted copy of the unit agreement which you have submitted for the proposed North Dagger Draw Upper Penn Unit, Eddy County, New Mexico. This agreement meets the general requirements of the Commissioner of Public Lands and has this date granted you preliminary approval as to form and content.

Preliminary approval shall not be construed to mean final approval of this agreement in any way and will not extend any short term leases, until final approval and an effective date have been given.

It is our understanding that no fresh water will be used for injection in this project.

When submitting your agreement for final approval, please submit the following:

- 1. Application for final approval by the Commissioner setting forth the tracts that have been committed and the tracts that have not been committed.
- 2. All ratifications from the Lessees of Record and Working Interest Owners. All signatures should be acknowledged by a notary and one set must contain original signatures.
- 3. Order of the New Mexico Oil Conservation Division and approval by the Bureau of Land Management. Our approval will be conditioned upon subsequent favorable approval by the New Mexico Oil Conservation Division and the Bureau of Land Management.
- 4. A copy of the Unit Operating Agreement.
- 5. A copy of your Initial Plan of Operation.
- 6. A re-designation of well names and numbers.
- 7. On Exhibit "B", please update the correct lessees of record as noted in the enclosed copy.

- 8. There are several communitization agreements that will no longer be required when this agreement is approved. Please advise this office which communitization agreements need to be terminated upon approval of this unit agreement.
- 9. On Exhibit "B", please do not mix the tracts. Please list the Federal tracts together, State tracts together, and Fee tracts together. The Federal tracts should be listed first, the State tracts should be listed second and the Fee tracts should be listed last. Please include a recapitulation of the total Federal, State and Fee acreages and percentages on the last page of Exhibit "B".
